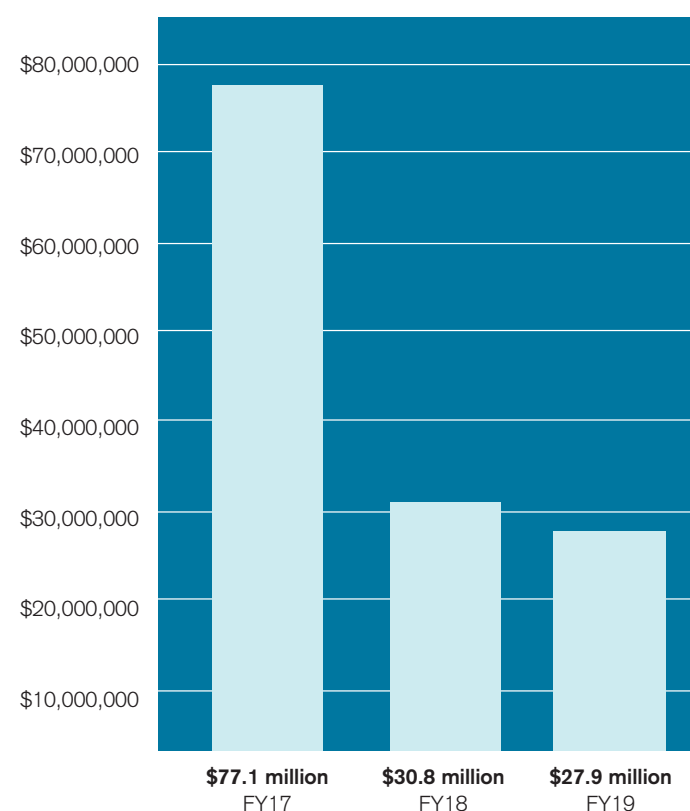

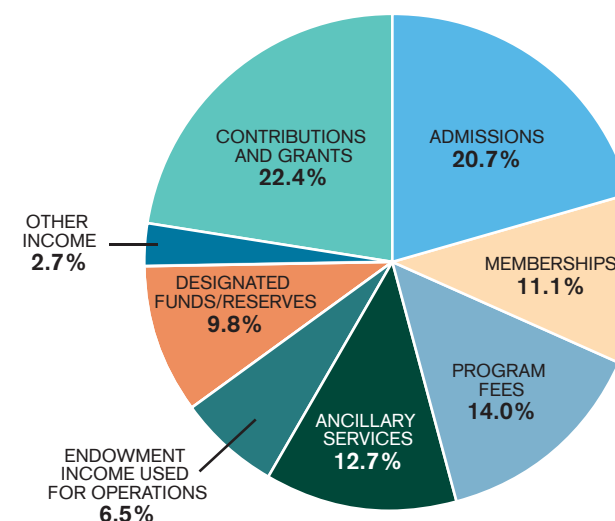

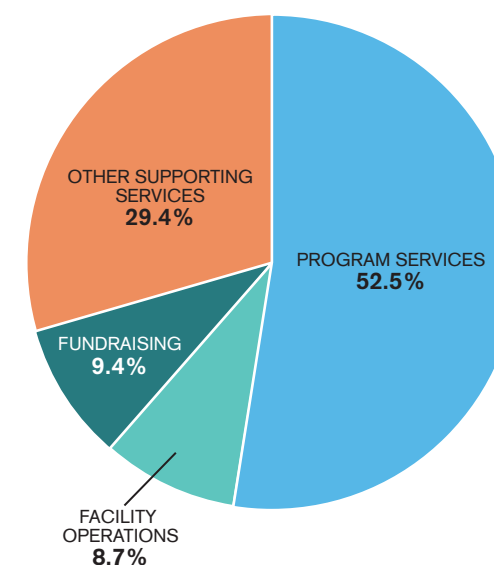

## FISCAL YEAR 2019 HIGHLIGHTS

- David Mugar made a \$3 million gift that will support the conversion of the Mugar Omni Theater, a beloved New England icon, from 70mm film projection to a state-of-the-art 4k/digital laser projection system.
- The Lowell Institute, the Museum's longest-standing supporter, received the 2018 Colonel Francis T. Colby Award, the institution's highest philanthropic recognition. A relationship between the two major New England institutions stretches back to 1840 when Yale professor Benjamin Silliman gave the first Lowell Lecture.
- At the conclusion of a three-year effort, the Museum surpassed its \$20 million goal and raised \$23.5 million for the Blue Wing Founders Fund, which will support the transformation of the Blue Wing. This impressive figure was reached after a successful matching fund challenge by trustee emerita Brit d'Arbeloff generated \$3 million.
- Estimated author Margot Lee Shetterly received the 2018 Bradford Washburn Award. She wrote *Hidden Figures: The American Dream and the Untold Story of the Black Women Mathematicians Who Helped Win the Space Race*.
- The Museum raised a record \$783,000 at its 10th annual signature celebration Stars of STEM. Vertex Pharmaceuticals Chairman, President, and CEO Jeffrey Leiden, M.D., Ph.D. accepted the 2019 Star of STEM Award on the company's behalf.
- Dariush Mozaffarian, MD, DrPH received the 2018 Walker Prize, which recognizes meritorious published scientific investigation and discovery.
- Visitors flocked to the Museum to see engaging temporary exhibitions including *All Aboard! Trains at Science Park*, *Wild Kratts: Ocean Adventure*, *Nature's Superheroes*, and *BODY WORLDS & The Cycle of Life*.
